Postal Ballot	Management	Approve sale of the South Region Divestment Business of Linde India Limited along with other assets to Air Water India Private Limited for Rs. 13.8 bn in line with Competition Commission of India's (CCI) directive	For	For	The CCI issued a directive to divest some assets in order to give effect to the global merger of Linde AG (ultimate holding company of Linde India Limited) and Praxair Inc. In line with this, the company has identified Air Water Private Limited as the successful bidder with an offer of Rs. 13.8 bn for slump sale of the South Region Divestment Business together with other assets. Since the sale price is discovered via a bidding process, we support the transaction. Notwithstanding, the company must address the concerns raised by minority investors on the proposed delisting of Linde India Limited (the first voluntary delisting offer failed due to the discovered price of Rs. 2,205 per share being rejected by the acquirer). Further, while the company announced that it was exploring the option of merging the company with the Indian arm of Praxair Inc, it has not provided any clarity since the original announcement. The company should have provided clarity on the merger plans before the open offer was announced.

He has been on the board of the company for close to 12 years (since January 2008). Although his reappointment is compliant with regulations, we consider directors to be non-independent once they cross a tenure of ten years from the date of their first appointment. Therefore, we do not support his reappointment as an independent director. The board must consider reappointing him as a non-independent non-executive director.

Postal Ballot	Management	Reappoint Arun Balakrishnan (DIN: 00130241) as Independent Director for five years from 1 October 2019	For	For	Arun Balakrishnan, 69, is Former Chairperson and MD, Hindustan Petroleum Corporation Limited. He has been on the board of the company for close to eight years (since November 2011). His reappointment is in line with statutory requirements. We will consider him as Non-Independent once his overall tenure on the board exceeds ten years and will assess board composition accordingly.

He was working as Vice President-Tonnage Accounts Management of the company since 2014. Abhijit Banerjee's estimated 2019 remuneration of Rs. 33. 3 mn is in line with peers and commensurate with the size and complexity of the business. The company must provide clarity on the variable component of the remuneration payable to him.
